Deployments that Qualify as Technical Rescue The Training Committee will review the wording of the T-002 form to see if we need to change it so rescues that don't currently appear to qualify as "technical" but should, will qualify – example being our deployment to Spectacle Lake. In that deployment, responders camped out overnight and the litter and wheel were carried up to the dog's location but not used to transport the dog back to the trailhead. Thus, the equipment was not 'used' as is outlined on form T-002 and no technical skills were utilized.

Potential Presentation to Fire Departments

- How can we get our name out to different groups that haven't heard of us? The first Monday of every month there is a Chief Association meeting in Snohomish County. Jeff's brother can get us in to give a short presentation.
- King county has same monthly meeting, along with a training consortium meeting that we can try to get into for a presentation.

Jeremy suggested we go to a Union Meeting and will help Jeff set something up.

<u>Technical Rescue Training at Fire Dept. 21</u> After first of year, Jeff will set up a group training with technical rescue at Fire Department 21.

Greta and Bill agreed that if they sign into the roster (A-21) and sign the Emergency Assignment and Identification form (A-020) they should be covered.
