#### Washington State Animal Response Team August 8<sup>th</sup>, 2024 19:00 – 21:00 Via Zoom BOD Minutes

**In attendance:** Leo Notenboom, Noah Bernays, Michaela Eaves, Lynn Snow, Julie Shipman, Jeff Dahl, Bill Daugaard, Jenifer Clark, Kimberly Taylor, Gretchen McCallum, Rory Kelleher

The August 8<sup>th</sup> meeting was called to order at 19:01.

#### **Priority Discussion and Decision Items:**

County Animal Response Team (CART) in Clark County

- WASART member and ACO Paul Batchelder contacted the Board in late June looking to form a CART in Clark County, asking if the Board would consider incorporating it under WASART's umbrella organization (command structure, insurance policy, etc.)
- **For** the formation of a Clark CART:
  - A CART would allow a significant number of ACO's, domestic animal/livestock professionals, and law enforcement in Clark County the opportunity to join WASART who feel excluded due to distance to trainings and deployments.
  - Response time to Clark County area deployments would be reduced.
  - Clark County could operate in a manner analogous to the TRT (which is already semi-autonomous) and be the "Clark TRT".
  - WASART has already established a protocol with Clark County OEM for responding within Clark County.
- **Against** the formation of a Clark CART:
  - A similar discussion was had regarding a CART formation in Clallam County in approximately 2011, but it never went anywhere because the process got too complicated to resolve (and it was thought to be unlikely to find a critical mass of responders in other counties).
  - Although semi-autonomous, TRT and TWRT have been imbued with WASART culture over the past 17 years. An autonomous team in a different county may not adhere to the same standards of safety, professionalism, chain of command, respect, etc.
  - Covering an unknown team under WASART's insurance policy would significantly increase WASART's liability.
  - WASART gathers resources from the 3 largest and richest WA counties, which allows the organization to keep operating—if Clark County is unable to maintain itself financially, would WASART be required to help them buy equipment, etc.?
  - Expansion could require a paid, full-time director.
  - Clark responders are unlikely to attend TRT's monthly training, making it difficult to verify that they will be trained to a high enough and safe enough caliber to operate under WASART's name.
- Conclusion:
  - While the Board applauds the effort and motivation, WASART will not incorporate Clark County as a CART under its organizational umbrella.
  - WASART is happy to support Clark County's independent formation or formation under their local Office of Emergency Management by providing realistic expectations on the work involved in such an endeavor and supplying supporting documentation/resources (vendor lists, nonproprietary operating procedures, finance tips, joint training, etc.)

- WASART's President will relay tonight's discussion to Paul and invite him to come chat with members of the Board.

  - No one has volunteered to take over as TWRC Chair. Rory will stay on as Chair in the interim.

#### Treasurer – Gretchen McCallum

- Total donations deposited in July: \$ 3,652.13
- New fraudulent check issue
  - A while ago, there was a \$ 16k scam that compromised WASART's original bank account. Federal agents caught 6 of these check-washers who were part of a multi-million dollar scam, all of whom pleaded guilty. WASART has since changed bank accounts, and the bank reimbursed WASART in full.
  - A new fraudulent check made out to David Kiki, for \$ 16,724 .45, arrived last week.
  - Gretchen received a call from the Royal Canadian Bank in Ottawa, who confirmed that the account number was that of WASART's old, compromised account. No money has been removed from WASART's new account. Gretchen will send the new fraudulent check to the Department of Justice who will open a new case against the scammers.

- Spectacle Lake almost-deployment for an injured husky
  - Despite WASART standing down after the owner walked the husky out, WASART developed a better working relationship with Kittitas County Deputy Mike Bruce.
  - Because of the potential for a 22-mile round trip hike and the probability of an overnight deployment with few backcountry-experienced responders, local SAR

was requested. At first, Kittitas was reluctant to respond for an animal. When it was brought to their attention that Ed Christian (King County Deputy and SAR coordinator) regularly allows SAR resources to assist on WASART deployments, and when the situation was posed as "rather than responding to help an animal, you're responding to help WASART," Kittitas SAR agreed to assist.

- Mike Bruce agreed to meet about mutual aid agreements between WASART and Kittitas County (arrangements for this meeting need to be made).
- Luna deployment (Great Dane packout)
  - WASART member Joy Waugh made a video of the packout from start to finish
  - Total reach of the video: 132,500, including 1,288 plays on Instagram, with an average watch time of 22 seconds, resulting in many new followers
