• Work parties

- Currently, the gear cleaning responsibilities are not assigned to anyone specific but tend to fall on the same 3 – 5 people, which has led to frustrations among those putting in the work.
- Possible ideas to improve this system:
 - Incentivize work parties (make gear cleaning a requirement for the TRT earned shirts, to become deployment-eligible, or to complete EAS/B&O trainings. Maybe create a similar earned shirts program just for work party attendance).
 - Create instruction sheets so cleaners do not need to be experts.
 - Publicize the cleaning work as a critical mission function.
 - Clean gear on weekends to possibly attract more people even if it means waiting a few more days post-deployment.
 - Offer multiple (~3) options for gear cleaning dates.
 - The Board will discuss further at the November meeting.
- Trailer1 will be out of commission for about a week this month for replacement/repair of rear ramp surface new marine grade plywood and paint with grit for better grip in slippery conditions.
- MAXTRAX traction boards total of 3 sets (1 for each tire) now in W2 (box truck) and W3 (Ram truck). W1 has one set due to space limitations. When Rory completes the build out, if there is space available, more can be added.
- Flat nose shovels being added to W2 & W3 to assist with dig outs of vehicles or animals.
- LED taillights with backup light being upgraded on T1 (TRT) and T2 (Lg Animal Sheltering).
