#### Information & Communications Technology – Leo Notenboom

- 2 tablets for Supply arrived. Accessories ETA this week, plus setup time.
- Issues with MailChimp, if we plan to revive the public newsletter
  - Cost kicked in (\$45/mo)- not worth it, given our limited use it (alternative services all in the same ballpark)
  - Stale list—WASART has not sent anything in a long time
  - Getting a flood of illegitimate signups (30-40 a day)
  - Self-hosted alternative (https://sendy.co/)- optimized for AWS but works locally
  - Migrating existing subscribers will be a process
  - Recommend we disable signups until we have a plan
- November website traffic presented in agenda
- Server move planned, likely around Christmas
  - Current host (InMotion) lost trust with support issue
  - New host (Contabo) significantly less expensive
  - Server management software will change (cPanel-> Webmin)
  - Potential delays in WASART.org emails during change-over
